In accordance with the requirements of Regulation 33 of the SEBI (Listing Obligations and Disc1osure Requirements) Regulations, 2015, the statutory auditors have performed an limited review of the standalone financial results of the Company for the guarter. ended 30th September, 2022. There are no modifications in the audit reports.

The Financial results have been prepared in accordance with Indian Accounting Standards ('Ind AS') prescribed under Section 133 of Companies Act, 2013 read with relevant rules thereunder and in terms of regulations of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended).

As the Company has only one Operating Segment, disclosure under Ind AS 108-Operating Segment is not applicable

Previous period's figures have been re-grouped/re-classified to render them comparable with the figures of the current period. 6. The Company has incurred a net loss of Rs.1,174.35 lakhs for the six months ended September 30, 2022, and accumulated losses. as on September 30, 2022 stand at Rs. 2,360.52 lakhs resulting in erosion of its net worth. The management has considered the possible impact of the losses and disruption caused by restriction imposed to contain COVID-19 spread, on the Company, including of assessment of liquidity and going concern assumption and carrying value of assets, as at 30th September, 2022. Based on such assumption, it has concluded that none of the assets are likely to be impaired and Company will be able to continue as a going concern for a forseeable future.

Exceptional item included the impairment loss in respect of building for Rs. 1,256.40 lakhs on the basis of valuation report dated 25 July 2022 by the registered valuer.
