### THE COMPANIES ACT, 2013

#### **MEMORANDUM OF ASSOCIATION**

#### OF

#### ADHBHUT INFRASTRUCTURE LIMITED (A Public Company Limited By Shares Incorporated under the Companies Act, 1956)

The following Memorandum of Association (MOA) was adopted pursuant to the Special Resolution passed by the Shareholders of the Company at the 30th Annual General Meeting held on 30th December, 2015, to bring the extent clauses of MOA in conformity with Table A of Schedule I to the Companies Act, 2013.

- **I.** The name of the Company is "ADHBHUT INFRASTRUCTURE LIMITED"
- **II.** The Registered Office of the Company will be situated in Union Territory of Delhi.

# III. (a) THE OBJECTS TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION ARE

- 1. To Purchase, acquire, take on lease or through any other lawful manner any land, buildings and structures and to develop the same and dispose of or maintain the same and build township, markets, commercial complex and all or related conveniences thereon and to equip the same or any part of other buildings, or any related amenities or conveniences such as drainage, roads, electricity etc.
- 2. To engage in real Estate Promoters, Developers & Project Management Association including civil, mechanical, electrical and all other types erection, commissioning projects, project trading as well as consultant for execution of projects on turnkey basis for equipments of industrial, domestic and other purpose.
- 3. To buy, exchange, purchase or otherwise acquire interest in any immovable property such as houses, buildings, market, shops, industrial sheds & lands, investment & Property investment within or outside the limits of municipal corporation or such other local bodies and to provide roads, drains, water supply, electricity and lights, within these areas, to divide the same into suitable plots and rent or sell the plots to the people for building, houses, bungalows farmhouse & colonies for workmen according to schemes approved by improvement trusts, development boards and municipal boards there on and to rent or sell the same to the public and realize cost in Lump-su, or on installments or by hire purchase system; or otherwise to start any housing scheme in India or abroad.

- 4. To purchase, take on lease, or exchange, hire or otherwise acquire sell and mortgage any estates, lands, agricultural lands, buildings, basements or such other interest in any immovable property and to develop and turn to account by building, multistoried buildings and altering, pulling down, decorating, maintaining, furnishing, fitting up and improving buildings and by paying, draining and letting building on lease and on rent.
- 5. To construct, execute, carry out, equip, maintain, improve, develop civil and constructional work relating to roads, electric, power, heat and light supply work, hotels, buildings, godowns, pleasure ground, parks, gardens, docks, jitries, embankements, bunds, bridges, wharts, canals, irrigation reclamations improvement, sewage, sanitary telegraphic, telephone works, warehouses, markets, public buildings and all other such civil and related constructional works and convenience of public utility.

# B) MATTERS WHICH ARE NECESSARY FOR FURTHERANCE OF THE OBJECTS SPECIFIED IN CLAUSE III(a) ARE:-

- 1.To enter into partnership or into any arrangement for sharing profits or loss of any union of interest joint venture, reciprocal concession or co-operation, with any person or persons or company or companies carrying on or engage in or about to carry on or engaged in any business or transaction which the company is authorize to carry on.
- 2.Subject to the provisions of the Companies Act 2013, and regulations made there under , and the directions issued by the RBI to borrow or raise or secure the payment of money in such manner and/or such terms and with such rights, powers and privileges and may be thought fit and determined from time to time and in particular by the issue or sales of any debenture, debenture stock, bonds bills of exchange, promissory notes or other obligations or securities of the company with full power to make the same transferable by delivery or by instrument of transfer or other wise and either perpetual or terminable and either redeemable or otherwise and to change or secure the same by trust deed or otherwise on the understanding of the company or upon any specific property and rights, present or future of the company upon such terms and conditions as may mutually be arranged, provided that the company shall not do any Banking business with in the meaning of the Banking Regulation Act, 1949.
- 3. Subject to the provisions of Companies Act, 2013 and directions issued by Reserve Bank of India to receive the money deposits on interest or otherwise and to lend money and negotiate loans with or without security to such

companies, firms of persons , and on such terms as may seem expedient, and to guarantee the performance or contracts by any person, companies or firms provided the company shall not carry on the business of banking and to guarantee the payment of money unsecured or secured or payable under or in respect of promissory notes, bonds, debentures, debenture-stock, contracts, mortgages, charges, obligations instruments and securities of any company or of any authority, supreme, municipal, local or otherwise or of any persons whomsoever, whether incorporated or not incorporated and to guarantee or become sureties for the performance of any contracts or obligations as may be necessary for purpose of the Company.

- 4. To establish and /or support aid in the establishment and support of associations, institutions, clubs, societies, funds, trusts, and conveniences calculated to benefit employees or ex-employees of the company or the dependants or the connections of such persons or subject to the provisions of the Companies Act, 2013 to subscribe or guarantee money for any charitable, national, religious benevolent, general or useful object or fund, or for any purpose which may likely, directly or indirectly, further the objects or Company or the interest of its members or business.
  - 5. To apply for, purchase or otherwise acquire, any patents, brevets d'invention, licenses, concessions, protections, rights, privileges, and the like conferring any exclusive or non exclusive or limited right to use or any secret or other information as to invention which may seem capable of being used for any of the purposes of the company of the acquisition of which may seem calculated directly or indirectly to benefit the company or may appear likely to be advantageous or useful to the company and to use exercise develop or grant licences, privileges in respect or otherwise turn to account the property, rights or information so acquired and to assist, encourage and spend money in making experiments test improvements of all inventions, patents and rights which the company may acquire or propose to acquire, and to dispose of copyrights, rights of representation, licences and any other rights or interest in any book, paper pamphlet, drama, play, poem song, composition (musical or otherwise), picture, drawing, work of art or photograph, and to print publish or cause to be printed or published any thing of which the company has a copyright or right to print or publish, and to sell distribute and deal with any matter so printed or published in such manner as the company may think fit and to grant licences or rights in respect of any property of the company may think fit and to grant licences or rights in respect of any property of the company to any other person, firm or company.

- 6. To acquire, and take over either the whole or any part of the business, goodwill trade marks, patents etc., and property assets and liabilities of any person or persons, firm or corporation, carrying on any business which the company is authorized to carry on and to establish branches and agencies of the company in India and elsewhere and to discontinue the same whenever necessary and to pay for any property or rights acquired by the company either in cash, or fully or partly paid up share or by the issue of the securities or partly in one mode and partly in another and generally on such terms as may be determined.
- 7. Subject to provisions of Companies Act, 2013 and the Rules framed thereunder and directions issued by the RBI from time to time to borrow or raise money on any terms without security or on the security of land, buildings, factories, machinery tools, bills of exchange, promissory notes, bonds, bills of landing, warrants stock, shares, debentures, debenture stock, book debts, stock or bonds either at par premium or discount and either redeemable or irredeemable, secured upon all or any part of the undertaking rights and properties of the Company present and future including its uncalled capital or the called but unpaid capital of the Company and to purchase, redeem, pay off of satisfy such securities, undertak9ing of the Company and properties, of every description or any one or more of them, and to receive money on deposit or/and loans from persons having dealings with the Company upon such terms as the Company may approve for the business of the Company.
- 8.To draw accept, endorse, discount, execute and issue or negotiate cheques, bills of exchange, promissory notes, hundies, bills of lading, and other negotiable instruments.
- 9.To advance or lend moneys such person or persons and upon such terms as may seem expedient and in particular to customer or and other persons having dealing with the Company and to guarantee the performance of contracts by members or persons having dealing with the Company. Provided that company shall not do any Banking business within the meaning of Banking Regulation Act, 1949.
- 10. To make advances to any trust firm, Company or Co-operative Society having dealing with the Company with or without security, and upon such terms as the Company may approve.

- 11.To engage, employ, suspend and dismiss executive, engineers, agents, managers, superintendent, assistants, clerks and other servants and labourers and to remunerate any such person at such rate as shall be thought fit, to grant bonus, compensation, pension or gratuity to any such person or to his widow or children and provide for the welfare of all employees.
- 12.To pay for any property' rights or privileges, acquired by the Company or for the services rendered or to be rendered in connection with the property of the Company or otherwise either wholly or partly in cash or in shares, bonds, debentures or other securities of the Company and to issue any shares either as fully paid up or with such amount credited as paid up thereon, as may be agreed upon and to charge any such bonds, debentures or other securities upon all or any part of the property of the Company. While so doing the Company shall comply with all the requirements of law for the time being in force.
- 13.To insure all or any or the properties or obligations of the Company whatsoever nature against any risk whatsoever.
- 14.To create any depreciation fund, reserve fund, insurance fund, sinking fund, or any other special fund excluding funds for particular purpose subject to section 293A of the Act, whether for depreciation or repairs, replacement, improvement, extension or maintenance of any of the properties of the Company by way of development rebate reserve or for redemption of debentures or redeemable preference shares or for any other purpose conducive to the interests of the Company.
- 15. To expand money in experimenting, developing , planning and testing and improving or seeking to improve any patents, right, inventions, discoveries, processes or information of the Company or which the Company may acquire or propose to acquire.
- 16.To invest in other than investment in company's own shares and deal with the moneys of the Company not immediately required in such manner as may from time to time seem expedient and be determined by the Company.
- 17. To make any loan to any person on any terms whatsoever provided that the Company shall not carry on the business of banking as defined under the Banking Regulation Act, 1949 and the grant of such loan does not tantamount to carrying on banking business.

- 18.To set up joint venture anywhere in the world by providing know-how for such products or business as may be manufactured or carried on by the Company and to provide such know-how in consideration of moneys calculated on the sales or net profits of the joint venture or partly in one mode and partly in another and to also participate in the equity capital of any such joint-venture.
- 19.Subject to the provisions of the Companies Act, 2013 to place, to reserve or issue bonus shares among the members or otherwise to apply as the Company may from time to time think fit any moneys belonging to the Company including those received by way of premium on shares or debentures issued by the Company at a premium and any moneys received in respect of dividends accrued on forfeited shares and moneys arising from their issue by the Company of forfeited shares.
- 20.To enter into any arrangement or agreement with the Government or authorities, municipal, local or otherwise that may seem conducive to the objects of the Company or any of them and to obtain from any such Government or authority any rights, concessions and privileges which the Company may think fit and desirable, and to carry out exercise and comply with any such arrangements, rights, privileges and concessions.
- 21.To buy, lease or otherwise acquire or procure technical know-how and to sell, lease out or otherwise provide technical know-how to others whether in India or outside India.
- 22.To undertake and execute any trust which may be of benefit to the business of the Company directly or indirectly.
- 23.To form, incorporate or promote or join in the promotion of any Company or Companies whether in India or foreign having amongst its, or their objects the acquisition of all or any of assets, rights, liabilities or control, management or development of the Company or any other object or objects which in the opinion of the Company could or might directly or indirectly assist the Company in the management of its business or the development of its properties or otherwise prove advantageous to the Company and to pay all or any of the costs expenses incurred in connection with any such promotion or incorporation and to remunerate any person or company in any manner it shall think fit for services rendered or to be rendered in obtaining subscriptions for or placing or assisting to place or to obtain n subscriptions for or for guaranteeing the subscriptions of or the placing of

any bonds, debentures, obligations, or securities of the Company or any stock, shares, debentures, obligations or securities of any other company held or owned by the Company or in which the Company may have any interest or the conduct of its business or in or about the promotion or formation of any other company in which the Company may have an interest.

- 24. To enter into partnership or any other individual arrangement for sharing profits, co-operation, joint venture, reciprocal concession, licence or otherwise with any person, firm, association, society or body corporate carrying on or engaged in or about to carry on or engage in any business or transaction capable or being conduced so as directly or indirectly to benefit the Company and to give any special rights, licences and privileges in connection therewith and in particular the right to nominate one or more persons or person whether they be shareholders or not to be directors of such Company.
- 25. Subject to Sections 391 to 394 of the Act, to amalgamate with any other company having objects altogether or in part similar to those of this company.
- 26.To sell or sublet any concession licence obtained or contracts entered into and to sell the whole or any part thereof for such consideration as the Company may think fit of the property and business of the company for cash or for shares whether fully paid up or not, debentures or securities of any other company or partly in cash, or partly in such shares, debentures or securities as distributed in specie among the members or otherwise.
- 27.To carry on any other business whether manufacturing or otherwise that may seem to the Company capable of being advantageously or conveniently carried on in connection with to the above objects or calculated directly or indirectly to enhance that value of or render profitable any of the Company's property or rights or which it may be advisable to undertake with a view to improving, developing, rendering valuable or turning to account any property real or personal belonging to the Company or in which the Company may be interested.
- 28.To institute and defend any suit, appeal, application for review, for revision or any other application of any nature whatsoever, to take out executions to enter into agreements of reference to arbitration and to enforce and where need to contest any awards and for all such purpose to engage or retai9n counsels, attorneys and agents and when necessary to remove them.

- 29.To assist any other company under the same management within the meaning of the Companies Act, 2013 or any statutory modification thereof, in any manner and to any extent including the giving of loans and guarantee the providing of securities of any kind whatsoever in connection with any loan given to the latter by any person, firm or body corporate.
- 30.To do all or any of the above things either as principals or agents, trustees, contractors or otherwise and wither alone or in conjunction with others and either by or through agents, subcontractors, trustees or otherwise, in connection with the business of company.
- **IV.** The liability of the member(s) is limited and this Liability is limited to the amount unpaid, if any, on the shares held by them.
- V. The Share capital of the Company is Rs. 12,50,00,000/- (Rupees Twelve Crores fifty lacs only) divided into 1,10,00,000 (One Crore ten lacs) Equity shares of Rs. 10/- (Rupees Ten) each and 15,00,000 (fifteen lacs) Preference shares of Rs. 10/- (Rupees Ten) each.

#### SHARE CAPITAL AND VARIATION OF RIGHTS

- 3. Shares under control of Board Subject to the provisions of the Act and these Articles, the shares in the capital of the Company shall be under the control of the Board who may issue, allot or otherwise dispose of the same or any of them to such persons, in such proportion and on such terms and conditions and either at a premium or at par and at such time as they may from time to time think fit.
- 4. Directors may allot shares otherwise than for cash Subject to the provisions of the Act and the Articles, the Board may issue and allot shares in the capital of the Company on payment or part payment for any property or assets of any kind whatsoever sold or transferred, goods or machinery supplied or for services rendered to the Company in the conduct of its business and any shares which may be so allotted may be issued as fully paid-up or partly paid-up otherwise than for cash, and if so issued, shall be deemed to be fully paid-up or partly paid-up shares, as the case may be.
- 5. Kinds of Share The Company may issue the following kinds of shares in accordance with these Articles, the Act, the Rules and other applicable laws:
  - (a) Equity share capital:
    - (i) with voting rights; and / or
    - (ii) with differential rights as to dividend, voting or otherwise in accordance with the Rules; and
  - (b) Preference Share Capital
- Issue of Certificate
   (1) Every person whose name is entered as a member in the register of members shall be entitled to receive within two months after allotment or within one month from the date of receipt by the Company of the application for the registration of transfer or transmission or within such other period as the

conditions of issue shall provide:

- (a)One certificate for all his shares without payment of any charges; or
- (b) Several certificate each for one or more of his shares, upon payment of such charges as may be fixed by the Board for each certificate after the first.
- Certificate to (2) Every certificate shall be under the seal and shall specify the shares to which it relates and the amount paid-up thereon.
- One certificate for Shares held jointly (3) In respect of any share or shares held jointly by several persons, the Company shall not be bound to issue more than one certificate, and delivery of a certificate for a share to one of several joint holders shall be sufficient delivery to all such holders.
- 7. Option to receive share certificate or hold shares with depository
  A person subscribing to shares offered by the Company shall have the option either to receive certificates for such shares or hold the shares in a dematerialized state with a depository. Where a person opts to hold any share with the depository, the Company shall intimate such depository the details of allotment of the share to enable the depository to enter in its records the name of such person as the beneficial owner of that share.
- 8. Issue of new If any share certificate be worn out, defaced, mutilated or certificate in torn or if there be no further space on the back for place of one endorsement of transfer, then upon production and defaced, lost or surrender thereof to the Company, a new certificate may destroyed be issued in lieu thereof, and if any certificate is lost or destroyed then upon proof thereof to the satisfaction of the Company and on execution of such indemnity as the Board deems adequate, a new certificate in lieu thereof shall be given. Every certificate under this Article shall be issued on payment of fees for each certificate as may be fixed by the Board.

- 15. Company's Lien on (1) The Company shall have a first and paramount lien: Shares (a) on every share (not being a fully paid share), for
  - all monies (whether presently payable or not) called, or payable at a fixed time, in respect of that share; and
  - (b) on all shares (not being fully paid shares) standing registered in the name of a member, for all monies presently payable by him or his estate to the Company:

Provided that the Board may at any time declare any share to be wholly or in part exempt from the provisions of this clause.

Lien to extend to dividends (2) The Company's lien, if any, on a share shall extend to all dividends or interest, as the case may be, payable and bonuses declared from time to time in respect of such shares for any money owing to the Company.

- 16. Enforcing lien by sale The Company may sell, in such manner as the Board thinks it, any shares on which he Company has a lien: Provided that no sale shall be made:
  - a) unless a sum in respect of which the lien exists is presently payable; or
  - b) until the expiration of fourteen days after a notice in writing stating and demanding payment of such part of the amount in respect of which the lien exists as is presently payable, has been given to the registered holder for the time being of the share or

to the person entitled thereto by reason of his death or insolvency or otherwise.

- Validity of Sale (1) To give effect to any such sale, the Board may authorize some person to transfer the shares sold to the purchaser thereof.

The Company's lien shall prevail notwithstanding that it has received notice of any such claim.

Partial payment not to preclude forfeiture Neither judgment nor a decree in favor of the Company for calls or other moneys due in respect of any shares nor any part payment or satisfaction thereof nor the receipt by the Company of a portion of any money which shall from time to time be due from any member in respect of any shares either by way of principal or interest nor any indulgence granted by the Company in respect of payment of any such money shall preclude the forfeiture of such shares as herein provided. 30. Provided that such registration shall not be suspended for more than thirty days at any one time or for more than forty five days in the aggregate in any year.

#### WINDING UP

Subject to the applicable provisions of the Act and the Rules made thereunder:

- (a) If the Company shall be wound up, the liquidator may, with the sanction of a special resolution of the Company and any other sanction required by the Act, divide amongst the members, in specie or kind, the whole or any part of the assets of the Company, whether they shall consist of property of the same kind or not.
- (b) For the purpose aforesaid, the liquidator may set such value as he deems fair upon any property to be divided as aforesaid and may determine how such division shall be carried out as between the members or different classes of members.
- (c) The liquidator may, with the like sanction, vest the whole or any part of such assets in trustees upon such trusts for the benefit of the contributories if he considers necessary, but so that no member shall be compelled to accept any shares or other securities whereon there is any liability.

#### **INDEMNITY AND INSURANCE**
